## CIVIL SERVICE SAILING ASSOCIATION

The CSSC Sports and Leisure have made several changes to their membership rules in 2011 which automatically affect the CSSA. These changes now affect all members of CSSA in one or more ways.

Wider entitlement to join as a CSSC full member, called CSSC Qualifying Membership.

Membership of CSSC is now open to all types of government and state employees including local government, NHS, the armed forces, and all the bodies previously eligible.

CSSC Linked Membership now replaces CSSA Associate Membership.

Every CSSC Qualifying Member may now nominate up to three Linked Members who do not need to qualify as in section 1 above, and pay the same rates as a new Qualifying Member. It is intended that this will replace both Associate and Family CSSA Memberships, making all CSSA members also CSSC members.

Removal of the requirement for CSSC Membership Plus from 1 January 2012.

From 1 January 2012 all new and existing CSSA Members will only need to subscribe to the CSSC at basic Membership rates, not Membership Plus, and existing CSSA Members can have their rates halved, including those on old rates. There will be no additional central CSSA subscription, only local club fees.

Payment for Qualifying members will still be preferably by deductions from salary or government pension where a suitable arrangement exist, otherwise and for Linked Members payment will be possible by annual cheque, debit or credit card, or monthly, quarterly or annual direct debits.

For 2015 the subscription rates for new and renewing CSSC members will be £3.80 per month, £45.60 per annum for Qualifying Members on salary and Linked Members. For Qualifying Members on a government pension and Linked Members on a state pension it will be £3.43 per week or £41.16 per annum. Local CSSA club subscriptions will still be additional.

Separate CSSC forms are available for payment from salary/pension or payment by cheque/card/direct debit from CSSA and CSSC websites which can also be used to request the reduction from Membership Plus (this will not be done automatically for existing members). Forms should be sent to CSSC Sports and Leisure, FREEPOST HY656, High Wycombe HP13 5BR and **marked CSSA at the top**, or via Ken Pavitt.

Reduction of CSSA Temporary Membership to Day Membership

CSSA Temporary Membership will be discontinued and limited Day Membership will be available for £8 per day for sailing on club yachts for one introductory trip of up to 14 days only per person, once only after which the person will need to join in one of the above categories.
